AN ORDINANCE ACCEPTING PLAT OF FRANZEN'S FIRST SUBDIVISION IN THE VILLAGE OF GIFFORD, CHAMPAIGN COUNTY, ILLINOIS

WHEREAS, on the 5th day of May, A.
