

ORDINANCE NO. 23

AN ORDINANCE ACCEPTING PLAT OF ANNA K. FRANZEN'S SECOND SUBDIVISION IN THE VILLAGE OF GIFFORD, COUNTY OF CHAMPAIGN AND STATE OF ILLINOIS.

WHEREAS, on the _____ day of _____, A. D. 1959, a plat of ANNA K. FRANZEN'S SECOND SUBDIVISION IN THE VILLAGE OF GIFFORD, COUNTY OF CHAMPAIGN AND STATE OF ILLINOIS, together with the certificate of Godfrey Sperling, County Surveyor and Illinois Land Surveyor, Registry No. 796, who prepared said plat, and the Dedication and acknowledgment thereof by ANNA K. FRANZEN, a widow, the owner thereof, a true and literal duplicate original of which is attached hereto and made a part of this Ordinance by reference, was submitted to the President and Board of Trustees of the Village of Gifford, Illinois, for their consideration and approval; and

WHEREAS, the President and Board of Trustees of the Village of Gifford, Illinois, have found the aforesaid documents to be in all respects true, legal and sufficient, and that it is to the best interests of the Village of Gifford, Illinois, that the same be approved and accepted.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Gifford, Illinois:

Section 1. That the said plat of ANNA K. FRANZEN'S SECOND SUBDIVISION IN THE VILLAGE OF GIFFORD, COUNTY OF CHAMPAIGN AND STATE OF ILLINOIS, as described above, should be, and the same is hereby approved and accepted by the President and the Board of Trustees of the Village of Gifford, Illinois.


Section 2. That the President and the Village Clerk of the Village of Gifford, Illinois, be and they are authorized and instructed to indicate the approval of the aforesaid plat by the President and Board of Trustees of said Village of Gifford, Illinois, by dating and signing the approval shown on the face thereof, and that the Village Clerk be authorized to certify such approval and acceptance for the purpose of having the same recorded, as provided by law, in the following language which shall, to all intents and purposes, be held and regarded as sufficient evidence of the approval and acceptance thereof by the Village of Gifford, Illinois, viz:

I, William Johnson, Village Clerk of the Village of Gifford, Illinois, do hereby certify that the accompanying plat, hereto attached and designated as

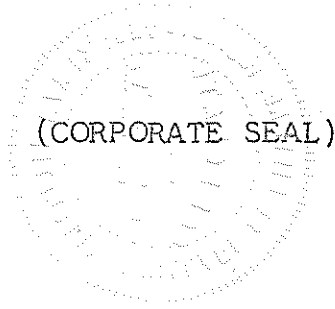

Section 3. This ordinance shall be in full force and effect from and after its passage as provided by law.


