AN ORDINANCE calling a special election to vote on the question of issuing \$60,000 Water Bonds of the Village of Gifford, Champaign County, Illinois.

WHEREAS, it is deemed advisable and necessary and for the best interests of the Village of Gifford that a new waterworks system be constructed in said Village in accordance with plans and specifications heretofore approved; and

WHEREAS, this Village has heretofore estimated the cost of such construction and does hereby estimate that it will cost not less than \$ 154,340.00 ; and

WHEREAS, funds are not available for the purpose of such construction as hereinabove described and it will, therefore, be necessary to issue revenue bonds to pay part of the cost thereof and to issue general obligation bonds to pay the balance of said cost, and before such general obligation bonds can be issued, the question of issuing said bonds must be submitted to the electors of said Village and approved by a majority of the electors voting on said question at an election called for that purpose.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Gifford, Champaign County, Illinois, as follows:

Section 1. That it is hereby determined to be in the interest of public health and safety that a new waterworks system be constructed in said Village as hereinabove described in the preamble of this ordinance, and for that purpose it will be necessary that this Village borrow money and in evidence thereof issue the bonds of said Village to the amount of \$60,000 for the purpose of paying part of the cost of such construction.

Section 2. That a special election is hereby called to be held in and for said Village on July 29, 1961,

between the hours of 6 o'clock A.M. and 6 o'clock P.M. of said day for the purpose of submitting to the electors of said Village the question contained in the form of ballot set out in Section 6 hereof.

Section 3. That for the purpose of said election the corporate limits of said Village shall constitute the boundaries of a single election precinct and the polling place for said election is hereby established at:

Hoch Building, Gifford, Illinois

Section 4. That the Village Clerk be and is hereby ordered and directed to cause notice of said election to be given by publishing notice thereof once in the Champaign-Urbana Courier, the same being a newspaper having a general circulation within said Village, there being no newspaper published in said Village. The date of such publication shall be not more than 30 days nor less than 15 days prior to the date set for said special election, and said notice as published shall be in substantially the following form:

PUBLIC NOTICE is hereby given that a special election will be held in and for the Village of Gifford, Champaign County, Illinois, on July 29, 1961, at which time there will be submitted to the electors of the said Village the following question:

Shall bonds in the amount of \$60,000 be issued by the Village of Gifford, Champaign County, Illinois, for the purpose of paying part of the cost of constructing a new waterworks system in said Village, maturing serially on January 1 in each of the years and in amounts as follows:

\$2,000 - 1964 through 1967  
3,000 - 1968 through 1973  
4,000 - 1974 through 1979  
5,000 - 1980 and 1981

and bearing interest at not to exceed the rate of 4-7/8% per annum?

That for the purpose of said election the corporate limits of the Village of Gifford shall constitute a single election precinct, and the polling place for said election shall be at:

Hoch Building, Gifford, Illinois

The polls at said election will be open at 6 o'clock A.M./<sup>C.D.S.T.</sup> and <sup>C.D.S.T.</sup> will be closed at 6 o'clock P.M./ of the date of the election. All persons qualified to vote at regular Village elections are qualified to vote on said question.

Shall bonds in the amount of \$60,000 be issued by the Village of Gifford, Champaign County, Illinois, for the purpose of paying part of the cost of constructing a new waterworks system in said Village, maturing serially on January 1 in each of the years and in amounts as follows:

3,000 - 1968 through 1973  
4,000 - 1974 through 1979  
5,000 - 1980 and 1981
