

TAX LEVY ORDINANCE

33

WHEREAS, the Board of Trustees of the Village of Gifford in the County of Champaign and State of Illinois, did on the 1st day of June A. D. 1961, pass the annual appropriation bill for said Village for the fiscal year beginning on the 1st day of April A. D. 1961, the amount of which is ascertained to be the aggregate sum of Twenty Thousand Four Hundred Forty - Dollars, which said appropriation bill was duly published on the 8th day of June A. AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR

BE IT ORDAINED by the Board of Trustees of the Village of Gifford Illinois:

Section 1. That there be and is hereby levied upon all the taxable property within the corporate limits of said Village of Gifford subject to taxation for the year, A. D. 1961,
