

Ordinance No. 37
ORDINANCE ESTABLISHING
CURFEW FOR MINORS

BE IT ORDAINED BY THE President and Board of Trustees of the Village of Gifford, Illinois, as follows:

Section 1. That it shall be unlawful for any minor under the age of fourteen (14) years to be on any street, alley, or any other public place in the Village of Gifford, after the hour of 10:30 o'clock P.M., unless and except accompanied by his or her parents or one of them, his or her legal guardian, or some other adult person responsible for his or her care and custody.

Section 2. It shall be unlawful for any minor of the ages of fourteen (14) years through seventeen (17) years, inclusive, to be on any street, alley, or any other public place in the Village of Gifford after the hour of 11:00 o'clock P. M. on Sunday through Thursday, or after 12:00 o'clock midnight on Friday or Saturday, unless and except accompanied by his or her parents or one of them, his or her legal guardian, or some other adult person responsible for his or her care and custody.

Section 3. Any minor person within the ages above set forth who shall violate this Ordinance or any section thereof, shall be subject to a penalty of not less than Three Dollars (\$3.00) nor more than Two Hundred Dollars (\$200.00) for each offense.

Section 4. Any parent, guardian, or other person having the legal custody or the control of any minor within the age limits above set forth, who shall allow said minor to be upon the streets, alleys, or other public places in the Village of Gifford, in violation of any of the provisions of this Ordinance, shall be subject to a penalty of not less than Three Dollars (\$3.00) nor more than Two Hundred Dollars (\$200.00) for each offense.

Section 5. This Ordinance shall be published in manner and form as is provided by law, by publishing the same in some newspaper of general circulation within the Village of Gifford, such publication to be made within ten (10) days after the passage and approval of this Ordinance.

Section 6. This Ordinance shall take effect ten (10) days after its publication as herein provided and as provided by law.
