ORDINANCE NO. 82

AN ORDINANCE PROVIDING FOR THE TAKING OF A LIMITED CENSUS IN THE VILLAGE OF GIFFORD, CHAMPAIGN COUNTY, ILLINOIS

BE IT ORDAINED by the President and Board of Trustees of the Village of

Gifford, Illinois:

SECTION I

That a census be taken in the territory hereinafter specified in the Village

of Gifford, Illinois for the purpose of ascertaining the population in the following

annexed territory of said village:

Ordinance No. 31 adopted March 16, 1961: Commencing at the Northeast (NE) corner of the Southeast Quarter (SE^I₄) of Section Two (2), Township Twenty-one (21) North, Range Ten (10) East of the Third Principal Meridian; thence along Quarter $(\frac{1}{4})$ Section Line, North Eighty-nine Degrees Forty-six Minutes West (N 89' 46'W), Two Hundred Ninety-seven (297.0') for a True Point of Commencing; On the Corporate limit line of the Village of Gifford; Thence continuing along said Quarter $(\frac{1}{4})$ Section Line, and Corporate limit line, North Eighty-nine Degrees Forty-six Minutes West (N 89) 46' W), Three Hundred Ninety-seven and Eight Tenths (397.8') feet; Thence South Four Hundred Seventeen (417.0') feet; Thence North Eighty-nine Degrees Fifty-two Minutes East (N 89° 52' E), Three Hundred Ninety-seven and Six Tenths (397.6') feet; to said Corporate limit line; Thence North Four Hundred Fourteen and Eight Tenths (414.8') feet to the True Point of Commencing. Containing Three and Nine Hundred Ninety-seven Thousandths (3.997) Acres. Situated in the Northeast Quarter (NE^{$\frac{1}{4}$}) of the Northeast Quarter (NE^{$\frac{1}{4}$}) of the Southeast Quarter (SE_4^1) of Section Two (2), Township Twenty-one (21) North, Range Ten (10) East of the Third Principal Meridian, County of Cham paign and State of Illinois, said above tract being known as the Leischner First Addition to Gifford, in Champaign County, Illinois.

Ordinance No. 44 adopted November 2, 1961: Lots 1, 2 and 3 in Roessler Addition to Gifford, Illinois and that portion of Lot 4 in Roessler Addition to Gifford, Illinois which prior to November 2, 1961 had not been within the Village of Gifford, Illinois, and that portion of the South 30 feet of the Southeast 1/4 of the Southeast 1/4 of the Southeast 1/4 of Section 2, Township 21 North, Range 10 East of the 3rd Principal Meridian in Champaign County, Illinois, which prior to November 2, 1961 had not been within the Village of Gifford, Illinois.

Ordinance No. 51 adopted August 2, 1962: A tract of land in the Northeast Quarter of Section 2, Township 21 North, Range 10 East of the Third Principal Meridian in Champaign County, Illinois, described particularly as follows: Beginning at the intersection of the South right-of-way line of State Bond Issue Route 119 and the West line of the H. G. Wise Subdivision, which point is 60.00 feet South and 638.18 feet West of the Northeast corner of aforementioned Section 2; thence South 0° 22' East 886.05 feet to the Southwest corner of Lot 11 of H. G. Wise Subdivision; thence South 89° 15' West 290.60 feet; thence North 0° 22' West 111.49 feet; thence North 89° 38' East 40.00 feet; thence North 0° 22' West 170.00 feet; thence South 89° 38' West 40.00 feet; thence North 0° 22' West 600.00 feet; thence North 89° 38' 38' East 290.00 feet to the place of beginning.

Ordinance No. 72 adopted November 5, 1964: Beginning 30 feet West of the Northwest corner of Lot 15 of Leischner First Addition to Gifford, Illinois; thence West on the North line of said addition projected 150 feet; thence South parallel to the line of New Street as platted in said Addition 830 feet; thence East 150 feet; thence North 830 feet to the place of beginning; containing 2.858 acres in the Northeast Quarter of the Southeast Quarter of Section 2, Township 21 North, Range 10 East of the Third Principal Meridian, Champaign County, Illinois, being known as the Leischner Second Addition to Gifford, in Champaign County, Illinois.

Section II

That a census taker shall be named by the President and Board of Trustees of said Village for the purpose of ascertaining the exact information as to the number of inhabitants in the annexed territory.

Section III

That after the said census is taken, the same shall be subscribed and sworn

to by the census taker as being true and correct and shall be filed with the Village Clerk.

Section IV

That the compensation of said census taker shall be the sum of $\frac{25^{20}}{25}$.
