## ORDINANCE NO. 101 <u>LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT</u> FISCAL YEAR

WHEREAS, the President and Board of Trustees of the Village of Gifford, CHampaign County, Illinois, did on June 6, 1968, pass the Annual Appropriation Bill for said Village for the fiscal year beginning April 1, 1968 and ending March 31, 1969, the amount of which is ascertained to be the aggregate sum of \$53,450.00, which said Appropriation Bill was duly published on June 15, 1968;

NOW THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Gifford, Illinois:
