

ORDINANCE NO. 158

LEVY AND ASSESSMENT OF TAXES FOR THE  
CURRENT FISCAL YEAR

WHEREAS, the Mayor and Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on the 1st day of May, 1980, pass the Annual Appropriation Bill for said Village for the fiscal year beginning April 1, 1980 and ending March 31, 1981, the amount of which is ascertained to be the aggregate sum of \$277,345.85, which said Appropriation Bill was duly published on May 9, 1980;

NOW THEREFORE, BE IT ORDAINED by the Mayor and the Board of Trustees of the Village of Gifford, Illinois:

SECTION I

That there be and is hereby levied upon all taxable property within the corporate limits of the Village of Gifford, Illinois, subject to taxation for tye year 1980, the total sum of \$167,245.85 for the following specific purposes mentioned in said Appropriation Bill and in the respective sums as follows:

SECTION II


That the Clerk of said Village of Gifford, Illinois, is hereby directed to file with the County Clerk of Champaign County a duly certified copy of this ordinance.

SECTION III


That this ordinance shall take effect and be in force from and after its passage and approval.
