

ORDINANCE NO. 198

LEVY AND ASSESSMENT OF TAXES FOR THE
CURRENT FISCAL YEAR

WHEREAS, the Mayor and Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on the 1st day of May, 1986, pass the Annual Appropriation Ordinance for said Village for the fiscal year beginning April 1, 1986, and ending March 31, 1987, in the aggregate sum of \$252,000.00, which said appropriation ordinance was duly published on May 10, 1986;

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Gifford, Illinois:

That there be and is hereby levied on all taxable property of the Village of Gifford, Illinois, subject to taxation for the year 1986 the total sum of \$36,656.00 as hereinafter enumerated and levied.
