

ORDINANCE NO. 206

LEVY AND ASSESSMENT OF TAXES FOR THE
CURRENT FISCAL YEAR

WHEREAS, the Mayor and Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on June 4, 1987, pass the Annual Appropriation Ordinance for said Village for the fiscal year beginning April 1, 1987, and ending March 31, 1988, in the aggregate sum of \$247,634.00, which said appropriation ordinance was duly published on June 9, 1987.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Gifford, Illinois:

SECTION I

That there by and is hereby levied on all taxable property of the Village of Gifford, Illinois, subject to taxation for the year 1987 the total sum of \$33,808.00 as hereinafter enumerated and levied.

SECTION II

There is hereby levied upon all said taxable property for general corporate purposes the sum of \$9,100.00 as follows:

SECTION VIII


That the Clerk of said Village of Gifford, Illinois, is hereby directed to file with the County Clerk of Champaign County a duly certified copy of this ordinance.
