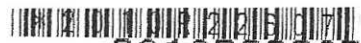

ORDINANCE NO. 299

An Ordinance for the Erection of Traffic Control Devices at a Certain Intersection

WHEREAS, it has been determined that additional traffic control devices are necessary for the safety and welfare of population;

WHEREAS, copies of such notices required to be recorded, if any, have been recorded in the Office of the Recorder of Champaign County; and

NOW THEREFORE, be it ordained by the President and Board of Trustees of the Village of Gifford, Champaign County, Illinois, as follows:

Section 1: THAT the following described intersections shall have erected stop signs requiring the drivers of vehicles to stop before entering the intersections:

<u>Street</u>	<u>Direction</u>	<u>Street</u>
West	Northbound	North
West	Southbound	North

Section 2. THAT all ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, the extent of such conflict, hereby repealed.

Section 3: THAT the Village Clerk is hereby directed to record with the Recorder and to file with the County Clerk a certified copy of this Ordinance, together with the accurate map of the territory annexed appended to the Ordinance.

Section 4: THAT this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
