

TAX LEVY ORDINANCE

No 60

WHEREAS, the ¹ Board of Trustees of the ² Village of Gifford in the County of Champaign and State of Illinois, did on the 6th day of June A. D. 19 63, pass the annual appropriation bill for said ³ Village for the fiscal year beginning on the 1st day of April A. D. 19 63, the amount of which is ascertained to be the aggregate sum of \$29,250.00 Dollars, which said appropriation bill was duly ⁴ published on the 8th day of June A. D. 19 63. Now, therefore

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR

BE IT ORDAINED by the ¹ Board of Trustees of the ² Village of Gifford Illinois:

Section 1. That there be and is hereby levied upon all the taxable property within the corporate limits of said Village subject to taxation for the year, A. D. 1963,

the total sum of Four Thousand (\$4,000.00) Dollars, for the following specific purposes mentioned in said appropriation bill and in the respective sums as follows, to-wit:
