

ORDINANCE NO. 69

TAX LEVY ORDINANCE

WHEREAS, the President and Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on the 4th day of June, A.D. 1964, pass the Annual Appropriation Bill for said Village for the Fiscal Year beginning on the 1st of April 1964 and ending on the 31st day of March 1965, the amount of which is ascertained to be the aggregate sum of \$44,416.50, which said Appropriation Bill was duly published on the 9th day of June 1964;

NOW, THEREFORE:

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR

BE IT ORDAINED by the President and Board of Trustees of the Village of Gifford, Illinois;

Section I

That there be and is hereby levied upon all taxable property within the corporate limits of said Village of Gifford, Illinois, subject to taxation for the year 1964, the total sum of \$13,914 for the following specific purposes mentioned in said appropriation bill and in the respective sums as follows, to-wit:
