

ORDINANCE NO. 81

TAX LEVY ORDINANCE

WHEREAS, the President and Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on the 6th day of May 1965 pass the Annual Appropriation Bill for said Village for the fiscal year beginning on the 1st day of April 1965 and ending on the 31st day of March 1966, the amount of which is ascertained to be the aggregate sum of \$52,425, which said Appropriation Bill was duly published as required by law on the 12th day of May 1965,

NOW THEREFORE:

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR

BE IT ORDAINED by the President and Board of Trustees of the Village of Gifford, Illinois:

Section 1

That there be and is hereby levied upon all taxable property within the corporate limits of said Village of Gifford, Illinois, subject to taxation for the year 1965, the total sum of \$26,325.00, for the following specific purposes mentioned in said appropriation bill and in the respective sums as follows, to-wit:
