

ORDINANCE NO. 129

ORDINANCE ANNEXING CERTAIN REAL ESTATE

WHEREAS, ILLINI F S INC., as sole owner of the real estate described below has duly petitioned this Board to annex the real estate described below to the Village of Gifford, and

WHEREAS, said real estate is not within the corporate limits of any municipality, but it is contiguous to the Village of Gifford, in Champaign County, Illinois, and

WHEREAS, said real estate is not in a Fire Protection District or Public Library District that is different from the Village of Gifford, and

WHEREAS, the Board has determined that it is for the best interest of the Village that said real estate be annexed to the Village and it is in all respects suitable for annexation by the Village pursuant to Section 7-1-8 of the Illinois Municipal Code.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF GIFFORD, ILLINOIS, that the following described real estate situated in Champaign County, Illinois:

A rectangular tract described as beginning at the Southeast corner of Section 35, Township 22 North, Range 10 East of the Third Principal Meridian, thence North 240 feet along the East line of said Section, thence due West 340 feet parallel with the South line of said Section, thence due South to a point on the South right-of-way line of U. S. Highway Route #136, thence East 340 feet along said right-of-way line to the East line of Section 2, Township 21 North, Range 10 East of the Third Principal Meridian, in Champaign County, Illinois, thence North along the East line of said Section 2 to the place of beginning, situated in Champaign County, Illinois

is hereby annexed to the Village of Gifford in accordance with the provisions of Section 7-1-8 of the Illinois Municipal Code.

PETITION TO ANNEX TO VILLAGE OF GIFFORD

TO: BOARD OF TRUSTEES OF THE VILLAGE OF GIFFORD, ILLINOIS

The undersigned petitioner on oath states that:

1. Illini F S, Inc., successor to Champaign County Service Company, a corporation, is the sole owner of the following described real estate except that portion used for public highway:

A rectangular tract described as beginning at the Southeast corner of Section 35, Township 22 North, Range 10 East of the Third Principal Meridian, thence North 240 feet along the East line of said Section, thence due West 340 feet parallel with the South line of said Section, thence due South to a point on the South right-of-way line of U. S. Highway Route #136, thence East 340 feet along said right-of-way line to the East line of Section 2, Township 21 North, Range 10 East of the Third Principal Meridian, in Champaign County, Illinois, thence North along the East line of said Section 2 to the place of beginning, situated in Champaign County, Illinois.

2. It is not within the corporate limits of any municipality;

3. Said real estate is contiguous to the Village of Gifford, in Champaign County, Illinois;

4. Said real estate has no one residing on it.

5. Said real estate is not in a Fire Protection District or Public Library District that is different from the Village of Gifford.

6. Said real estate is in all respects suitable for annexation to the Village of Gifford, Illinois.

WHEREFORE the petitioner respectfully requests that the above described real estate be annexed to the Village of Gifford, Illinois, pursuant to Section 7-1-8 of the Illinois Municipal Code.

the motion. A roll call vote taken was as follows:


