

ORDINANCE NO. 136

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE
VILLAGE OF GIFFORD, CHAMPAIGN COUNTY, ILLINOIS

WHEREAS, DAVID W. ALBERS and CHRISTINE E. ALBERS, have presented their Petition to the Village of Gifford, Champaign County, Illinois, requesting that the following-described real estate be annexed to the Village of Gifford, to-wit:

Beginning at the Southeast corner of Lot 8 of a subdivision of a part of the West Half of the Southwest Quarter of Fractional Section 1, Township 21 North, Range 10 East of the 3rd P.M.; thence running West 144.2 feet on the south line of said Lot; thence North 30 feet parallel with the East line of said Lot to the point of beginning; thence North 122.22 feet parallel with the East line of said Lot; thence East 144.2 feet parallel with the North Right-Of-Way line of South Road; thence South 122.22 feet on the East line of said Lot; thence West 144.2 feet on the North Right-Of-Way line of South Road to the place of beginning, situated in Champaign County, Illinois,

and,

WHEREAS, said Petitioners are the owners of all land within such territory and, that there are no electors residing therein, other than Petitioners; and,

WHEREAS, the said real estate is contiguous to the corporate limits of the Village of Gifford, Illinois, and is not included within the corporate limits of any municipality; and,

WHEREAS, it is in the best interests of the Village of Gifford that the said land be annexed to the corporat limits of said Village.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Gifford, Champaign County, Illinois, that:

SECTION I


The following-described property be annexed to and included within the corporate limits of the Village of Gifford, Champaign County, Illinois, to-wit:

Beginning at the Southeast corner of Lot 8 of a subdivision of a part of the West Half of the Southwest Quarter of Fractional Section 1, Township 21 North, Range 10 East of the 3rd P.M.; thence running West 144.2 feet on the south line of said Lot; thence North 30 feet parallel with the East line of said lot to the point of beginning; thence North 122.22 feet parallel with the East line of said Lot; thence East 144.2 feet parallel with the North Right-Of-Way line of South Road; thence South 122.22 feet on the East line of said Lot; thence West 144.2 feet on the North Right-Of-Way line of South Road to the place of beginning, situated in Champaign County, Illinois

This Ordinance shall be in full force and effect from and after its passage, approval, and signing as provided by law.


