ORDINANCE NO. 183

LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR

WHEREAS, the Mayor and Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on the 5th day of May, 1983, pass the Annual Appropriation Bill for said Village for the fiscal year beginning April 1, 1983 and ending March 31, 1984, the amount of which is ascertained to be the aggregate sum of \$207,850.00, which said Appropriation Bill was duly published on May 1983;
