

ORDINANCE NO. 190

LEVY AND ASSESSMENT OF TAXES FOR THE
CURRENT FISCAL YEAR

WHEREAS, the Mayor and Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on the 7rd day of May, 1984, pass the Annual Appropriation Bill for said Village for the fiscal year beginning April 1, 1984 and ending March 31, 1985, the amount of which is ascertained to be the aggregate sum of \$266,600.00 which said Appropriation Bill was duly published on May 15, 1984;

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Gifford, Illinois:

SECTION I

That there be and is hereby levied upon all taxable property within the corporate limits of the Village of Gifford, Illinois, subject to taxation for the year 1984, the total sum of \$241,600.00 for the following specific purposes mentioned in said Appropriation Bill and in the respective sums as follows:
