## ORDINANCE NO. 206

# LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR

WHEREAS, the Mayor and Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on June 4, 1987, pass the Annual Appropriation Ordinance for said Village for the fiscal year beginning April 1, 1987, and ending March 31, 1988, in the aggregate sum of \$247,634.00, which said appropriation ordinance was duly published on June 9, 1987.
