

ORDINANCE NO. 219

LEVY AND ASSESSMENT OF TAXES FOR THE
CURRENT FISCAL YEAR

WHEREAS, the President of the Village of Gifford and the Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on June 7, 1990, pass the Annual Appropriation ordinance for said Village for the fiscal year beginning April 1, 1990 and ending March 31, 1991, in the aggregate sum of \$281,250.00, which said appropriation ordinance was duly published on the 13th day of June, 1990.

NOW THEREFORE, BE IT ORDAINED by the President of the Village and Board of Trustees of the Village of Gifford, Illinois:

SECTION I

That there be and is hereby levied on all taxable property of the Village of Gifford, Illinois, subject to taxation for the year 1990 the total sum of \$40,200.00 as hereinafter enumerated and levied.

SECTION II

There is hereby levied upon all said taxable property for general corporate purposes the sum of \$11,510.00 as follows:
