

ORDINANCE NO. 232

LEVY AND ASSESSMENT OF TAXES FOR THE
CURRENT FISCAL YEAR

WHEREAS, the President and Board of Trustees of the Village of Gifford, Champaign County, Illinois, did on May 6, 1993, pass the Annual Appropriation Ordinance for said Village for the fiscal year beginning April 1, 1993, and ending March 31, 1994, in the aggregate sum of \$309,650.00, which said appropriation ordinance was duly published on the 12th day of May, 1993.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Gifford, Illinois:

SECTION I

That there be and is hereby levied on all taxable property of the Village of Gifford, Illinois, subject to taxation for the year 1993 the total sum of \$44,450.00 as hereinafter enumerated and levied.

SECTION II

There is hereby levied upon all said taxable property for general corporate purposes the sum of \$12,950.00 as follows:
