

AMENDED ANNUAL TAX LEVY ORDINANCE 2009

An Ordinance levying taxes for all town purposes for **VILLAGE OF GIFFORD**, Champaign County, State of Illinois for the tax year 2009, collectible in 2010.

Be it **ORDAINED** by the Board of Trustees of **VILLAGE OF GIFFORD**, Champaign County, Illinois, as follows:

Section 1: That the sum of **\$69,595.00** are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized for the current year, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as:

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE
