BE IT ORDAINED BY THE MAYOR AND THE VILLAGE BOARD OF THE  
VILLAGE OF GIFFORD, ILLINOIS, as follows:

**Section 1:** Section 19 of prior Ordinance No. 64 being an Ordinance to regulate and license the sale of alcoholic liquor in the Village of Gifford, Illinois is hereby repealed.

**Section 2: DEFINITIONS.**


Unless the context specifically indicates otherwise, the meaning of terms used in this Ordinance shall be as follows:

- a) "Ordinance" means this ordinance and any amendments subsequently adopted.
- b) "Village" means the Village of Gifford, County of Champaign, State of Illinois.
- c) "Person" shall mean any individual, firm, company, municipal or private corporation, association, society, institution, enterprise, governmental agency or other entity.
- d) "President" means the President of the Board of Trustees of the Village of Gifford, Champaign County, Illinois.


**NOTICE TO RESIDENTS OF THE VILLAGE OF GIFFORD**
