

ORDINANCE NO. 37
LEVY FOR FISCAL YEAR 2013-2014

BE IT ORDAINED by the President and Board of Trustees of the Village of Gifford, Champaign County, Illinois:

Section 1: That the total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of ONE MILLION ONE HUNDRED FIFTY-NINE THOUSAND SIX HUNDRED AND NO ONE-HUNDRETHS DOLLARS (\$1,159,600.00).

Section 2: That the sum of ONE MILLION ONE HUNDRED FIFTY-NINE THOUSAND SIX HUNDRED AND NO ONE-HUNDRETHS DOLLARS (\$1,159,600.00), being the total of appropriation heretofore legally made that are to be collected from the tax levy of the current fiscal year of the Village of Gifford for all corporate purposes of said Village, for purposes for providing a General Fund, Illinois Municipal Retirement Fund, Police Protection Fund, Audit Expense Fund, Liability Insurance Fund and Social Security Fund, as appropriated for the current fiscal year by annual appropriation ordinance of the Village of Gifford for the Fiscal Year 2013-2014, passed by the President and Board of Trustees of said Village at the legally convened meeting of September 5, 2013, passed by the President and Board of Trustees of said Village at the legally convened meeting of September 5, 2013, be, and the same is hereby levied upon all of the taxable property in the Village of Gifford subject to taxation for the current year, the specific amounts as levied for various funds heretofore named being included herein by being placed in separate columns under the heading "To Be Raised by Tax Levy" that appears over them, the tax so levied being for the current fiscal year of said Village, and for the said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as follows:

That the said several sums of money are hereby appropriated from monies received by the Village of Gifford, Illinois, from all sources.

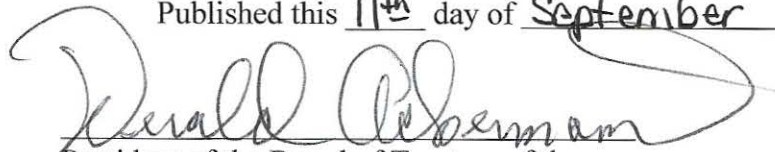
SECTION III:

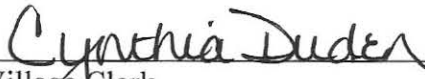
